- First Commission in 50 years
- Created by Presidential Executive Order
- Swear in January 22, 2020

#### Aetna Medicare

- Open Enrollment for Medicare eligible members and spouses.
- Ultimate Goal by January 2021 to reach 25,000 members and spouses enrolled
- If we reach this benchmark, Aetna has agreed to offer the FOP a Nationwide health care plan for members under Medicare eligibility age.
- Team meeting with Aetna at their corporate office February 18, 2020, to develop marketing strategies and goals.

#### FOP Financial Corp (For Profit)

- CMS (Center for Medicare Service) rules do not allow unions (FOP) to receive admin fees nor commissions.
- <u>We will receive an administrative fee from CMS</u>
- SF&C, our contacted broker will receive half the administration fee.
- We must have a for profit corporation to receive the funds. I will propose a resolution at our spring meeting to create this corporation.



# GOALS

- 1. <u>Create a Marketing Position located in Nashville</u>
- 2. Reach 25,000 Medicare enrollees
- 3. Pay corporate expenses through income and transfer remaining income 100% fund National FOP Foundation and expand services
- 4. Create a FOP Nationwide Healthcare plan for all members and their families regardless of age.
- 5. Create a National FOP Healthcare Trust to provide healthcare services to Lodges. During contract negotiations, Lodges can bargain stipends for health benefits and the FOP Trust will offer this benefit focusing on quality rather than profit.

#### Program Development

- Cipola Insurance licensing agreement
- Committee had several programs for review by the committee for recommendations to the board

#### **DART Trailer**

- \$160,000 in donations pledged, \$85,000 received
- Moving forward with the purchase of equipment and retrofitting
- Identified a trailer for \$60,000. Would require and additional \$75,000 (Estimate) to convert into a mobile kitchen
- Made a verbal offer Jason Smith is going to inspect
- Formalized partnership with UPS for transportation of the trailer.
- Completing sponsor process with Aetna and CVS.

#### Voter Voice

- Eboard negotiated and approved subscription to Voter Voice
- VOTERVOICE helps the FOP implement a smart, proactive approach to online governmental affairs.
- Allows our members to:
  - o Communicate with members with Congress
  - o Track Progress
  - Mobilize supporters



#### United Healthcare for Employees

- 19 employees opted into healthcare
- Renew policy with a 2% increase in premium
- Add vision benefit for all employees

#### **<u>Starbucks</u>** (Do not release outside the FOP until we formalize an agreement)

- Meet with Starbucks Executive Vice President John Kelly
- Recognizes a very small percentage of their partners have a law enforcement bias
- Early discussions interested in partnering on an educational collaboration and a national campaign to humanize police
- Also, wishes to weigh in on the lack of prosecution in some cities which is making their store locations unsafe and, in some cases, result in closing profitable locations dues to employee safety concerns.

#### Cops and Kids & CNN

- Revived a request from CNN for location of Cops and Kids Events
- Requested feedback from states
- Revived nearly 100 event locations across America.
- CNN chose coverage in Atlanta
- Cobb County FOP initiated this with their paying of lunch fees at a local school. Well done!

#### Vision 20/20

- Completed planning sessions in four locations with more than 160 attendees, Denver, Philadelphia, Nashville and Deerfield Beach, FL
- Developed Missions and Vision Statements and identified core values.
- Identified opportunities, strengths and weaknesses
- Prioritized goals and discussed paths for achievement
- Committee will compile the data from all four locations into an overall report and delivered to the National Board of Trustees for action

#### <u>Marketing</u>



- LE Group providing a \$50,000 Grant Humanizing Police
  - o Goal is to develop social media videos
  - o showing the role police officer play in their communities,
  - Contrast to the personal contributions as a stakeholder in their own communities.
- <u>Social Media</u>:
  - The marketing committee has been working diligently at growing our following through a more aggressive stance on issues that directly affect our members and having a strong voice on topics when it is appropriate. Each post is discussed and researched among the social media committee and refined prior to posting on our platforms. Our growth rate is as follows:
    - Facebook: 31% increase in likes to our page 61,800 > 81,032
    - Twitter: 15% increase in followers 18,500 > 21,300
    - Instagram: We started this page with zero followers and have 3,172 followers now.

#### • Video Production:

- Two videos have already been produced.
  - The first was a sketch video that contained statistics from some university studies about police use of force. It was released last month.
  - The second is the Windfall elimination video. It is in the finalized stages but expect it to be ready for release very soon.
  - The Video production team has met via teleconference several times to develop a framework of direction we want to go in. After much discussion, we have developed a series of video topics we would like to produce and roll out. Those topics are:
    - History of the FOP This video script is already being finalized and we will move into production soon.
    - Meet the board
    - What does the FOP do for you / Why should you be a member?
    - Community Outreach Video
    - Officer Wellness

- Two congressmen are slated to attend and speak at this meeting.
- Ways and Means Chairman Neil's introduced a WEP/GPO Bill
- Ways and Means Raking Member Baker's also introduced a WEP/GPO Bill
- Hopeful Neil and Baker can reach a compromise.

- Requested a law enforcement participation

#### Disaster Relief

#### <u>Data system – update</u>

- Set timeline for delivery of systems with a goal of substantially completing within one year
- Within weeks, launching member log in and rewards for completing profiles.
  - Will allow better demographics
  - o Identify specific employers
  - Will allow better marketing options

#### Journal Realignment

- Presently pay in excess of \$600,000 a year for four issues.
- Receive just over \$100,000 a year in ad sales.
- Contract up for renewal January 2021
